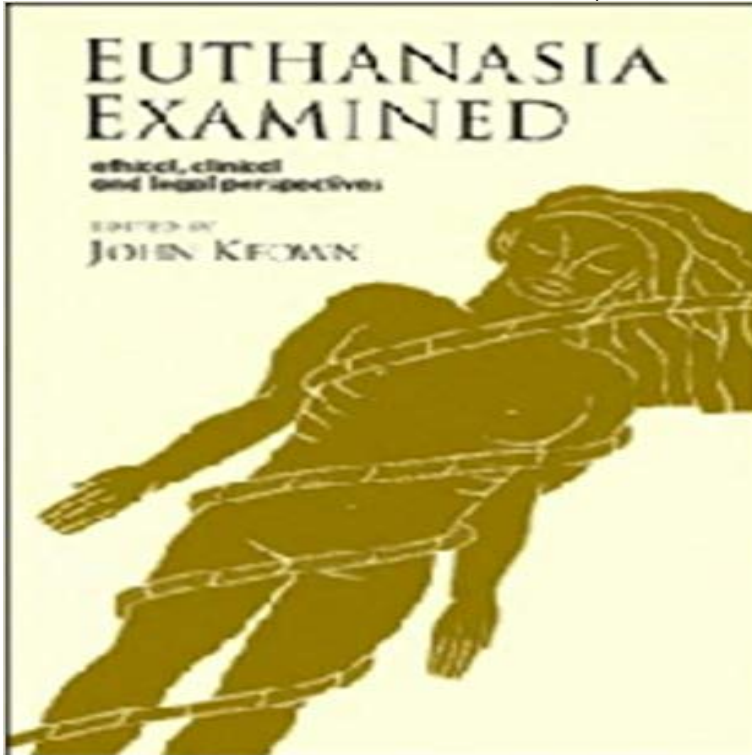


## Euthanasia Examined: Ethical, Clinical and Legal Perspectives
